"...but is it preaching?"

My most recent class (which isn't quite over; I'm still working on the final paper) was called "Preaching Across Platforms." I went into it without the slightest idea what that title meant. What is a *platform*? I wondered. And how does one go about preaching *across* platforms?

I'm still not sure I fully understand what preaching *across* platforms means. I guess I'm just a bit too much of a language stickler; *across* to me indicates a path from one to the other, and that's not really what we worked on in class. What the class was trying to get us to think about is whether preaching can take place in other formats or settings besides a sermon, delivered in a sanctuary, during a worship service. First we had to determine what we think *preaching* is. Then we needed to identify other *platforms* where we might be called on to speak, and then answer the question whether such speaking moments can be considered preaching. By *platforms* the professor meant other settings or styles; in class we each had to deliver a proclamation in another platform. We had two poems—one as though delivered at a reading focused on poems based on Biblical texts, the other a "slam" (competition) poem—a simulated podcast, and a mini-TED talk. (A TED talk has a person speaking for 20-30 minutes on a topic of interest; if you go online you can find them on all sorts of subjects. My classmate had to call his a "mini" TED talk because we weren't given that much time to speak.) Can those be considered preaching?

My final paper focuses on two other platforms: a Memorial Day observance at a local VFW post and the memorial lesson that takes place at annual Sacred Harp singings and conventions. Are they preaching? How do we know? As with myself, my three classmates, and our professor, each person has a different definition of *preaching* and what an appropriate setting for preaching might look like.

But this isn't just a topic we preachers need to think about. All Christians have opportunities to *proclaim* their faith, to talk about what Jesus has meant for us, and I'm still Baptist enough to believe it's important that all Christians do so whenever and however we're able. Are there settings in which that's okay and others in which it isn't? Are there places where we would be quite comfortable making such a statement, and others where we wouldn't be? How do we know? How do we tailor our proclamation for different settings? If you were giving a testimony during a worship service, would you say something different from what you might say if you were talking to young people around a campfire? Would you say something different if your proclamation opportunity came in a conversation with a friend?

As we move toward Easter, toward that greatest proclamation of all—the Lord is risen indeed!—let's all think about the times and places where we might take a chance and share our faith.

#### First Christian Church Board Meeting Minutes February 18, 2024

Shawn Quick, Chair, called the meeting to order at 10:38 am. Chuck Lewis opened with prayer.

After review and additions, the agenda was unanimously adopted on a motion made by Judy Daniel and second by Carol Roberts.

The minutes of the January 21, 2024 meeting were included in the board packet and reviewed by members present. They were unanimously approved after the motion was made by John Daniel and seconded by Gary Coffman.

**Financial Reports**: The Profit and Loss report for January was reviewed by Carol Lewis. She states we had a very good month with a total income of \$20,200.00 and a net income of \$11,283.23. John Daniel noted that in January, people often give their offerings for the whole year, resulting in higher than normal income. The Balance Sheet was then reviewed. A motion to accept the Financial reports was made by Chuck Lewis, second by Kathy Wood and unanimously passed.

**Minister's Report:** Rev. Hulsey reports several telephone, text and in-person conversations with members, non-members and youth. She noted several meetings she attended, and a funeral and visitation she participated in. She reviewed the schedule for upcoming Lenten services and services for Holy Week.

#### **OLD BUSINESS:**

Dept. Chairs: Shawn Quick presented the list of Dept. Chairs for 2024. Carol Roberts reminded us that the Pastoral Support and Memorial Gifts committees need to meet to elect committee chairperson and to reestablish regular meetings.

North Wall: Chuck Lewis said that he talked with the painter and was told that he would begin in 2-3 weeks.

Kitchen Mats: Everett said he was going to check with Heckadon Auction about the floor mats they had.

#### **NEW BUSINESS:**

Lyssa Lile spoke of the Butler Chamber of Commerce Membership Renewal and Volunteer Opportunities letter that she received and included in the board packet. The annual fee is \$100.00. A motion made by Carol Roberts, seconded by Chuck Lewis, to renew our membership passed unanimously. John Daniel volunteered to help the Chamber with the annual Christmas Parade. Rev. Hulsey agreed to speak at one of the Chamber's meetings if they wanted her to.

**Membership**: Carol Roberts states the fellowship subcommittee met and planned the activities for the year. **Other Business:** There being no further business brought to the attention of the board, the meeting was adjourned on the motion by Carol Roberts, with second by Chuck Lewis.
