THE CLEARNESS COMMITTEE

In the Friends (Quaker) tradition, people facing important decisions sometimes call together a "clearness committee" to help them discern God's will. Parker Palmer offers some instructions for how such a committee might function.

"Behind the Clearness Committee is a simple but crucial conviction: each of us has an inner teacher, a voice of truth, that offers the guidance and power we need to deal with our problems. But that inner voice is often garbled by various kinds of inward and outward interference. The function of the Clearness Committee is not to give advice or "fix" people from the outside in but rather to help people remove the interference so that they can discover their own wisdom from the inside out...

"The Clearness Committee's work is guided by some simple but crucial rules and understandings. Among them, of course, is the rule that the process is confidential. When it is over, committee members will not speak with others about what is said and, equally important, will not speak with the focus person [the person seeking guidance from the committee] about the problem unless he or she requests a conversation."

A Clearness Committee meets for a set period of time (perhaps two hours). The group waits in prayerful silence, broken when the focus person begins by presenting their dilemma in a "concise but helpful" way, taking around 10-15 minutes. Following that description, committee members may ask questions, but *not offer advice or describe similar situations they have faced in their own lives*. Palmer explains: "Nothing is allowed except real questions, honest and open questions, questions that will help the focus person remove the blocks to his or her inner truth without becoming burdened by the personal agendas of committee members."

An honest, open question is not a leading question, but one in which the asker does not already have the answer in mind: "Did you ever feel like this before?" rather than "Didn't that make you angry?" Questions should be brief and to the point, and "go to the person as well as the problem—for example, questions about feelings as well as about facts."

The focus person responds to the questions as they are asked, and those responses will likely generate additional questions. Their responses should be full, but not overly long; as Palmer says, "Resist the temptation to tell your life story in response to every question!"

A Clearness Committee meeting should not become a grilling or cross-examination; it should be relaxed and gentle. Participants need not be afraid of silence; it doesn't mean the conversation has petered out but could mean that important inner work is taking place. If silence falls, spend it in prayer. The meeting is also not a social gathering; participants must resist the temptation to chitchat or cracking jokes to break tension.

The committee should "surround the focus person with quiet, loving space, resisting even the temptation to comfort or reassure or encourage, but simply being present with our attention and our questions and our care."

About fifteen minutes before the allotted time ends, the focus person may choose to ask committee members to mirror back what has been said—but as during the question period, mirroring does not permit participants to offer advice or fix the person. Instead, a participant reflects back to the focus person what they believe was said, notices their use of language and body language, and then asks whether their reflection is correct, whereupon the focus person may say, "Yes, that's me," or "No, that's not." More questions may be asked after or instead of this mirroring if the focus person prefers.

To close the meeting, Palmer says, participants should take five minutes or so to "celebrate and affirm the focus person and his or her strengths. This is an important time, since the focus person has just spent a couple of hours being very vulnerable."

There should not be disappointment or letdown if the focus person's problem is not "solved" at the end of the meeting. The process, and the Holy Spirit, continue working in the person long after the meeting ends. Committee members are called to continue to hold the focus person in prayer.

A caveat: Not every problem and not every person benefits from this process. A Clearness Committee might not, for instance, be appropriate for a person who is mentally, emotionally, or spiritually fragile. Prayerful discernment is required.
