Blessings of the Season

I think there is wisdom in beginning the holiday season with Thanksgiving—with a day specifically devoted to counting blessings and giving thanks. For many of us the season between Thanksgiving and New Year's Day is exceptionally busy and can also be a time when we're especially anxious—anxious about making sure we buy the right gifts for our loved ones, anxious about all the special events we feel we must attend, anxious about coordinating everybody's schedules and dietary needs at our holiday gatherings, anxious about the cost of it all.

Experts—even those who aren't at all religious—have told us that stopping regularly to give thanks is good for our mental health. It helps us to put the difficulties and anxieties of life in perspective and keep us from falling into despair.

Not only that, but when we focus on what we have to be grateful for, it allows us to avoid giving in to the "gotta do more, gotta be more" (h/t to *Dead Poets Society*) mentality that is all around us, especially in social media and advertising. Social media tends to show us others' "highlight reels," everybody posting a picture of themselves at their best, while we're all painfully aware of our own "blooper reels," and how much we can't even begin to live up to those carefully curated images. Advertising is all about convincing us we aren't good enough, rich enough, beautiful enough, stylish enough, whatever, and that people won't love us unless we give them the perfect (i.e., *expensive*) gifts. It's easy to fall into anxiety and despair if we take those messages to heart and let them dictate our behavior during the holiday season.

So we begin the season with a day of thanksgiving; but I would argue we'd do well to carry that spirit into every day of the season, to take a minute at the end of each day to look back over the day and find something for which we can give thanks. We might find that we can cope with the busyness and stress a whole lot better when we do that.









Elders-Diana Rich, Don Malan, Chuck Lewis, John Daniel, and Carol Roberts. Treasurer-Carol Lewis. Others present: Rev. Sharla Hulse, Phyllis McBrayer, Everett McBrayer, and Carol Ann Winburn.

Chuck Lewis, Vice-Chair, called the meeting to order at 10:43 AM. John Daniel opened with prayer.

After review and additions, the agenda was adopted on motion of Diana Rich and second by Judy Daniel.

The minutes of the Congregational Meeting of 11-3-24 and the minutes of the 10-20-2024 regular Board Meeting were reviewed. There was one correction to the Congregational minutes. On the nominations for Elders, it should have said 3 years not 2 years. After this correction, both sets of minutes were approved on motion of John Daniel and second by Kathy Wood.

Financial Reports: The October 2024 Profit & Loss and Balance Sheet financial reports, as of 10-31-2024, were reviewed by Carol Lewis, Treasurer. She noted the October income of \$9,533.79 and expense of \$9,877.68. Year-to-date income of \$97,059.59 and Y-T-D expenses of \$107,390.93. The October report was approved on motion of Diana Rich and second by Kathy Wood. The full reports are available and may be reviewed in the Church office.

Ministers' Report: Rev. Hulsey reviewed her November report that was included in the Board packet. She noted activities from November including meetings attended, several telephone calls, texts, and in-person conversations. She noted that Morning Prayer continues via Facebook Live at 7:00. She reminded everyone of the Thanksgiving Service on November 24th at the Ohio Street Methodist Church. She expressed a big "Thank You" to Carol Ann Winburn for organizing pulpit supply last week. She reminded everyone of the winter weather policy, and flu and cold season are here. Her full report is available and may be reviewed in the Church office.

OLD BUSINESS:

Printer/Copier Proposal Update: It was reported that Adm. Assistant Lyssa Lile made contact with 360 Document Solutions, as requested She was able to secure basically the same printer/copier at much more affordable price that fits in the proposed budget. A detail sheet is included with these minutes.

Changes to Insurance/Deductibles: Chuck Lewis reported he has talked with the insurance representative but details for next year are not available until after the rates are set. This should be completed soon, and the representative will set up a time to discuss after that is complete. Chuck Lewis will notify Shawn Quick, Carol Roberts, and Sharla Hulsey to meet and discuss. He stated if others are interested in meeting to let him know.

Liability Forms from groups using FCC (requested by insurance carrier): Securing the form will be finalize after meeting the insurance representative later in December.

Update on Concrete parking bumpers for parking lot: Nothing new to report. Everett McBrayer is still checking into options.

NEW BUSINESS: No new business was brought to the board today.
