## Should we really pray like this?!

As we begin Lent this month, many of us are considering ways to deepen our spiritual lives. Some of us will give up things we feel are getting between us and the relationship with God we want to have. Others will seek to take up a new spiritual practice, one of the spiritual disciplines like confession, fasting, or service. Others might wish to try a new way to pray, and I want to address one that many of us haven't tried, perhaps because we consider it to be shocking or even wrong.

It's called imprecatory prayer, and it's found throughout the Psalms. For instance, while we often stop reading Psalm 137 at verse 18, it continues from there. Verse 19 says, "O that you would kill the wicked, O God, and that the bloodthirsty would depart from me..." An even more dramatic example is found at the end of Psalm 137:

O daughter Babylon, you devastator!  
Happy shall they be who pay you back  
what you have done to us!  
Happy shall they be who take your little ones  
and dash them against the rock! (Psalm 137:8-9)

Psalm 137 clearly arose out of the experience of exile, in which the Babylonian Empire destroyed Jerusalem and God's Temple and carried many of the into a foreign land. It's an expression of a nation's profound grief. From that grief they cried out to God to exact retribution on those who have killed and exiled them. And yes, they pronounce blessing on those who bring about that retribution.

Is it appropriate for God's people to pray for revenge, or even the death of their enemies? Or is it a sin even to have such feelings?

The presence of such prayers in the Psalms, in the Bible, seem to indicate that we can bring the whole of our experience to God in prayer. If we are angry or grieving, God is there to hear our cries and even our rage. And if from our grief and rage we cry out for God to harm those who have harmed us, I think that's okay.

The late Old Testament scholar Walter Brueggemann said about the cry for revenge at the end of Psalm 137 that when God's people lay at God's feet our desire for retribution against our enemies, we give God the responsibility for taking such action, and let go of any desire to take it into our own hands. This makes room in our hearts and lives for something even more important: hope.

So yes, if you've been hurt, if you see wrongs being done that are being ignored, justified, or otherwise not made right, bring it to God in prayer, even if that prayer is an imprecatory prayer asking for retribution or the destruction of those who are doing harm. God hears the prayer, and recognizes the pain that prompts it. And when we put our desire for revenge in God's hands, God can unclench our angry fists so that we might bless and be blessed, and find hope for a better future.

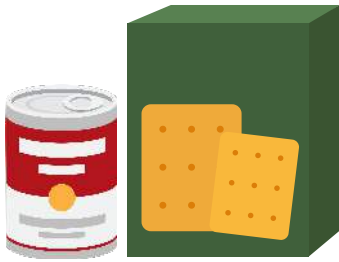

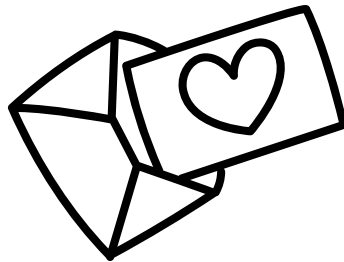

# Board Meeting Minutes

January 18, 2026

*Others present:* Rev. Sharla Hulsey, Carol Ann Winburn, and Claudia Hulsey.

The meeting was called to order at 10:38 a.m. by Carol Roberts, chairperson. Opening prayer was given by Diana Rich. The agenda was reviewed and requests to add Outreach, Pastoral Support, and Memorial committee reports were made. The agenda was approved unanimously after a motion was made by Justin Quick and seconded by Phyllis McBrayer.

The minutes of the December 2025 meeting were reviewed. No additions or corrections were made, motion to accept the minutes was made by John Daniel, seconded by Shawn Quick. Motion passed unanimously.

**Financial Reports**—Carol Lewis reviewed the financial reports for December 2025.

Budget vs. Actual—Total Income—\$8,652.63 (budget \$10,291.63)  
Total Expenses—\$15,038.92 (budget \$10,291.41)  
Net Income—\$-6,386.29

Carol noted that we had paid the annual workman's compensation fee, quarterly insurance fee and Building Repair and Maintenance costs that resulted in the negative income.

Motion made by Phyllis McBrayer to approve the financial reports, seconded by Diana Rich, and passed unanimously.

**Minister's Report**—Rev. Hulsey stated she had conversations with members in person, via telephone calls and texts. She attended the Disciple's Women meeting, the Elders meeting and the Ministerial Alliance meeting during the month. She also met with Jim Henry, Butler mayor, on behalf of the Ministerial Alliance concerning the need for a warming center in Butler during the cold weather. This center will not be available until next winter. She continues her daily morning prayer on Facebook. She is planning to take a brief vacation the weekend after Easter.

There was no old business.
